Minutes

Agenda Item: Welcome and Introductions

Commissioners and other attendees introduced themselves.

Agenda Item: Approval of Minutes

Jack Johnson moved to approve the previous meeting's minutes, Beth Harris-Robinson seconded the motion, and the motion passed unanimously.

Agenda Item: Adoption of 2024 Meeting Schedule

Commissioners were provided with the 2024 meeting schedule for their review and added a requirement for commissioners to attend a minimum of three of the four meetings in a calendar year. Hassan Latif moved to approve the motion, Jack Johnson seconded, and it passed unanimously.

Agenda Item: Commission Vacancy

The Commission engaged in discussion regarding how to fill a vacancy on the commission. Hassan Latif recommended Executive Director Jennifer Turner explore options for replacement with recommendations from the commission. James van Beek suggested compiling a list of prospective candidates with bios that can be shared with the commission. The commission concurred.

Agenda Item: Discussion and Adoption of Bridges Commission Policies

The Commission engaged in discussion regarding drafts of policies covering complaints regarding director, conflicts of interest, public comment, public records, and records retention. Commission members offered verbal edits to the documents and tabled adoption until the March meeting pending further refinement of the policies.

Agenda Item: Amendment to Executive Director Job Description regarding ADA accommodations

The Commission engaged in discussion of the amendment to the job description that adds a commitment to full inclusion. The addition adds a provision to provide reasonable accommodation requests related to Bridges' employment. It will be included in all job descriptions moving forward. Jack Johnson moved to approve, Beth Harris-Robinson seconded, and the motion was approved unanimously
