Agenda Item: Welcome and Introductions

Commissioners and other attendees introduced themselves.

Agenda Item: Approval of the March 2025 Minutes

Executive Director Performance Reviews:

Commission reappointments

The Bridges team in the 4^{th} Judicial District responded and collaborated with the participant, leading to finding supportive and stable housing for the participant.
